COMPLAINT

The Alabama Judicial Inquiry Commission ("Commission") brings this Complaint against Judge Leon Archer, Probate Judge of Tallapoosa County, Alabama. The facts and charges upon which this Complaint is based, averred separately and severally, are as follows:

NATURE OF THE CHARGES

1. Leon Archer (hereinafter "Judge Archer") took office as a Probate Judge of Tallapoosa County, Alabama on January 12, 2013, and has continuously served in that capacity until the present date. In his capacity as Probate Judge, Judge Archer issues marriage licenses and performs marriages.

Judge Archer also exercises jurisdiction over appointing guardians and setting up conservatorships.

2. This Complaint arises out of a Facebook relationship Judge Archer developed with a woman, hereinafter referred to as "J.T.", whom he met in his capacity as Probate Judge. The substance of the Complaint concerns sexually explicit dialogue, including sexual propositions and invitations, and photographs exchanged between Ms. J.T. and Judge Archer on the Facebook private-messaging service and over cell phone. Much of this dialogue occurred during office hours and from the office of the probate court. Although this dialogue began as a private interchange between Judge Archer and Ms. J.T., their conversations were preserved on their respective Facebook accounts and the nature of those conversations were made public when Ms. J.T. copied and released the dialogue to an Alexander City Outlook reporter.

3. Judge Archer's conduct described in this complaint demonstrates: a failure to uphold the high standards of conduct required of judges so that the integrity and independence of the judiciary may be preserved, a failure to avoid impropriety and the appearance of impropriety in all his activities, a failure to at all times maintain the decorum

and temperance befitting his office, and a failure to avoid conduct prejudicial to the administration of justice that brings the judicial office into disrepute.

Facts

4. Judge Archer first met Ms. J.T. on April 12, 2013, when she visited the probate office with Mr. W.T. to purchase a marriage license and have a wedding ceremony.

5. Judge Archer performed the ceremony. He took special note at the time that Ms. J.T. was 34 years old and Mr. W.T. was 68.

6. Judge Archer recalls that Ms. J.T. called his office approximately one week later. Ms. J.T. stated she wanted the marriage annulled. Judge Archer told her she would have to go to the circuit court for an annulment. The marriage was later annulled.

7. Judge Archer's third interaction with Ms. J.T. occurred in or around December of 2013 when Mr. J.T.'s daughter, W.M., filed a petition to establish a conservatorship and to appoint Ms. W.M. as guardian to protect Mr. W.T.'s assets.

8. Ms. J.T. called Judge Archer to ask that she, as the wife, be appointed guardian. Judge Archer informed Ms. J.T.

that she needed to get an attorney because Mr. J.T.'s daughter had already obtained an attorney who had applied for an emergency guardianship.

9. Ms. J.T. did not appear at the hearing on the guardianship when Ms. W.M. was made guardian of Mr. J.T.'s estate.

10. The marriage was annulled by order of the circuit court on June 11, 2014, pursuant to an agreement of the parties.

11. Judge Archer did not communicate with Ms. J.T. again until he found her on Facebook in or around July, 2015.

12. During or prior to July 2015, Judge Archer established a Facebook account under the profile name "Judge Leon Archer". His Facebook profile used a picture of himself in his judicial robe as his official profile picture. The profile page also identified him as the Probate Judge of Tallapoosa County, Alabama.

13. During the summer of 2015, Judge Archer sent Ms. J.T. a Facebook "friend" request, requesting her to confirm they would be Facebook friends and thus interact with each other via Facebook social media.

14. Ms. J.T. confirmed the "friend" request making Judge Archer and Ms. J.T. Facebook friends. This gave them ability to comment on each other's Facebook page as well as communicate privately via Facebook's private messaging service.

15. The Facebook messaging service allowed Judge Archer and Ms. J.T. to communicate with each other via private messages. Each such message sent to Ms. J.T. by Judge Archer identified the sender as "Judge Leon Archer." The contents of these messages were automatically saved and were available for future perusal and revelation.

16. On or about January 7, 2016, Judge Archer initiated a Facebook messaging conversation with Ms. J.T. that lasted approximately three weeks, ending Thursday, January 28, 2016.

17. This conversation included sexually explicit content, comments, and invitations or propositions. The messages also included pictures of the judge's genitals and a female's breasts, buttocks and genitalia.

18. On or around January 29, 2016, Ms. J.T. met with Mitch Steen, a reporter at the Alexander City Outlook ("The Outlook") and provided him a copy of the entirety of private messages between Judge Archer and Ms. J.T., including the

aforementioned nude pictures. On or about January 29, 2016, Judge Archer received a phone call from The Outlook's Mr. Steen requesting a meeting.

19. On or about January 29, 2016, Judge Archer met with Mr. Steen, who confronted him with a copy of the Facebook conversation between Judge Archer and Ms. J.T. Judge Archer admitted to the reporter that the Facebook messaging conversation occurred, including the transmittal of nude pictures.

20. On January 28, 2016 at 9:58 p.m. The Outlook published an article reporting that Judge Archer admitted "having sexually explicit conversations via social media messaging that included suggestive language and propositions for sexual acts." Exhibit A.¹

21. The Outlook article noted the Facebook messages from Judge Archer included his official Probate Judge portrait.

22. As described by the article, one message included an offer of money if the woman² with whom he was having the

conversation would meet him, quoting Judge Archer as stating, "What you doing today . . . I got some money to spend."³

23. The article reported that in the Facebook conversation, Judge Archer gave his personal cell phone number and invited calls to his office telephone number.

24. The article reported the messages from Judge Archer's Facebook account included a photo of a man nude below the waist which appeared to be taken in the men's restroom at the Tallapoosa County Courthouse.⁴

25. The article reported that the woman told the reporter, "I'm not innocent in this, I mean at first I figured he was just a lonely, nice man who wanted to talk. As the messages got suggestive, I couldn't believe it, but I didn't end it. I honestly thought it was funny in a weird way. But when he started talking about money, like I was a prostitute, that's when it hit me."

26. The article further reported the woman told the reporter that she could have "unfriended" Judge Archer at any time but that "he is an elected official - a judge. I couldn't believe he was doing this and wanted to see how far he would go. . . ."

27. The article reported further that the woman in one message asked, "Is it illegal for someone who holds elected county office to ask for sexual favors in exchange for money and ask the person to call their private line while they are at work?" Judge Archer responded, "Not if you call their personal cell #."

28. The article further reported that Judge Archer, upon being confronted by the reporter, apologized for the content of the article and the embarrassment caused by it; and stated that he had apologized to Ms. J.T.; his wife of 47 years; his family; his church family; his friends; and the people of Tallapoosa County.

29. Lastly, the article reported Judge Archer warned others against the dangers of social media.

30. A short article concerning Judge Archer's Facebook conversation also appeared on the internet news site, Al.com, on February 2, 2016. Exhibit B.

31. The Outlook article was reported in its companion newspaper, The Record, in Dadeville, Tallapoosa County Alabama on February 4, 2016. Exhibit C.

32. During the one month course of the conversation, Jude Archer and Ms. J.T. never met in person but communicated only through the Facebook messaging service and some text messages.

33. Judge Archer admits the conversation took place, admits the contents of the conversation as set out in the news articles and admits that Exhibit D is a true and correct copy of the conversation.⁵

34. Most of the conversations took place during work hours between 8 a.m. and 5 p.m. on work days.

35. The relevant conversations between Judge Archer and Ms. J.T. are set out below.

a. Thursday, January 7, 2016, 26 messages from 1:40 p.m. through 6:20 p.m.: Judge Archer attempting to set up a lunch date; sex talk beginning with Judge Archer replying to an offer for a tow or jumpstart

with, "Sweetheart I'm always needing a jump start. If you know what I mean. Lol"; and an exchange of telephone numbers.

b. Tuesday, January 12, 2016, 32 messages from 9:04 a.m. through 11:24 a.m.: exchanging of telephone numbers; a discussion of Ms. J.T.'s home and work address and her living situation; both expressing wishes to "see each other soon" and conveying excitement to "talk to [each other] face to face"; Judge Archer discussing his desire for a "special friend that I can share with and help me with some needs I have" with "[n]o strings attached."

c. Thursday, January 14, 2016, 40 messages from 11:39 a.m. through 3:56 p.m.: Judge Archer attempting to set up a lunch date; sex talk beginning with "I like the post you had, never ignore a horny woman"; discussions of relationships, sexually explicit pictures, arousing physical acts, and sexual act preferences; 6:42 p.m. through 12:41 a.m.: discussing sexually explicit matters, picture descriptions, and requests for additional pictures.

- d. Friday, January 15, 2016, 46 messages from 9:34 a.m. through 4:49 p.m.: concerning cancellation and rescheduling of a planned meeting; sex act preferences (spit or swallow); comments on nude or revealing pictures; pictures from Judge Archer to Ms. J.T.
- e. Sunday, January 17, 2016: Judge Archer requests sexually explicit pictures.
- f. Monday, January 18, 2016, 6 messages from 9:35 a.m. through 11:17 p.m: attempting to contact Ms. J.T. without responses.
- g. Tuesday, January 19, 2016, 10 messages from 9:06 a.m. through 11:17 a.m.: attempting to set up a meeting and giving Ms. J.T. his direct office number.
- h. Wednesday, January 20, 2016, 19 messages from 8:34 a.m. through 9:59 p.m.: attempting to set up a meeting; Judge Archer giving Ms. J.T. his direct office number; and Judge Archer sends a very sexually explicit message.
- i. Thursday, January 21, 2016, 10 messages from 9:10 a.m. through 4:19 p.m.: attempting to set up a

meeting and requesting sexually explicit pictures; at 9:19 a.m., Judge Archer asks, "What you got going today [?] Got some \$ that I need to spend"; at 1:31 p.m., Ms. J.T. sends a message expressing concern with the legality of an elected county official "asking for sexual favors in exchange for money and asking the person to call their private line during work." Judge Archer replies at 1:34 p.m., "Not if you call their personal cell #. I don't quite understand the question. I would not call their work #."

j. Friday, January 22, 2016, 9 messages from 9:48 a.m. through 2:14 p.m.: discussing exchanging pictures, meeting up, and Judge Archer asking, "[J.T], what happened to us hooking up[?]"

k. Saturday, January 23, 2016: Judge Archer requests a picture.

l. Tuesday, January 26, 2016, 31 messages from 10:19 a.m. through 4:33 p.m.: exchanging pictures and Judge Archer asks her to call his office or cell phone.

36. Exhibits A-D are attached hereto and are made a part of the record.

Charge I

Leon Archer, Probate Judge of Tallapoosa County, Alabama, while serving in that capacity, by communicating with a woman not his wife and former litigant in his court in an explicitly sexual manner via social media, by exchanging sexually explicit material, including photographs of genitalia, breasts and buttocks, and by propositioning the woman for sexual encounters, all described conduct occurring primarily during working hours, described in paragraphs 1 through 36 of this Complaint, violated those provisions of the Alabama Canons of Judicial Ethics which provide:

Canon 1 - A judge . . . should himself observe high standards of conduct so that the integrity and independence of the judiciary may be preserved.

Canon 2 - A judge should avoid impropriety and the appearance of impropriety in all his activities.

Canon 2A - [A judge] . . . should conduct himself at all times in a manner that promotes public confidence in the integrity and impartiality of the judiciary.

Canon 2B - A judge should at all times maintain the decorum and temperance befitting his office.

Canon 2B - A judge should . . . avoid conduct prejudicial to the administration of justice which brings the judicial office into disrepute.

Charge II

Leon Archer, Probate Judge of Tallapoosa County, Alabama, while serving in that capacity, by taking and transmitting a sexually explicit photograph of himself in the Tallapoosa County Courthouse and during working hours, described in paragraph 24 of this Complaint, violated those provisions of the Alabama Canons of Judicial Ethics which provide:

Canon 1 - A judge . . . should himself observe high standards of conduct so that the integrity and independence of the judiciary may be preserved.

Canon 2 - A judge should avoid impropriety and the appearance of impropriety in all his activities.

Canon 2A - [A judge] . . . should conduct himself at all times in a manner that promotes public confidence in the integrity and impartiality of the judiciary.

Canon 2B - A judge should at all times maintain the decorum and temperance befitting his office.

Canon 2B - A judge should . . . avoid conduct prejudicial to the administration of justice which brings the judicial office into disrepute.

Charge III

Leon Archer, Probate Judge of Tallapoosa County, Alabama, while serving in that capacity, by creating and maintaining a Facebook profile titled "Judge Leon Archer", by using a photograph of himself in his judicial robes, by identifying himself as "probate judge of Tallapoosa County, Alabama", and by displaying photographs of official court business, described in paragraph 12 of this Complaint, Judge Archer held out as his official judicial page the Facebook profile used to communicate the sexually explicit messages at issue, violated those provisions of the Alabama Canons of Judicial Ethics which provide:

Canon 1 - A judge . . . should himself observe high standards of conduct so that the integrity and independence of the judiciary may be preserved.

Canon 2 - A judge should avoid impropriety and the appearance of impropriety in all his activities.





JUDGE ADMITS SEXTING: Archer apologetic over sending sexually explicit talk, photos to younger woman

A Tallapoosa County judge has admitted having sexually explicit conversations via social media messenger that included suggestive language and propositions for sexual acts.

A 37-year-old female Facebook friend, who asked that her name not be used but did meet face-to-face with *The Outlook*, has supplied the newspaper with electronic copies of her conversations with Tallapoosa County Probate Court Judge Leon Archer.

The online conversations began in early January and escalated from friendly banter to sexually suggestive requests in a matter of days, according to time stamps on the messages.

Archer, who has been married for 47 years, apologized for his "very poor judgment."

"I'm not going to lie about it or deny it," Archer said after viewing prints of the messages Friday. "I'm not a perfect man and I have done a lot of things that I am not proud of and this may be one of the worst. I got caught up while on social media with my language and pictures going back and forth. It got out of hand and I should have known better.

"This shows a lapse of judgment – very poor judgment. Being a judge, I should be above that and adhere to a higher standard. I feel like I have voided that trust."

The messages appear to be from Archer's Facebook account, which features his official probate court judge portrait. One message even includes the offer of money if the woman were to meet with him.

"What you got going today ... I got some money I need to spend," Archer's message read.

Archer, who last year discontinued officiating marriages at the courthouse when he cited moral objections to same sex marriages, never said specifically what he wanted to spend the money on, which is a legal requirement to the crime of soliciting for prostitution.

The woman said when money was mentioned, she felt the banter had gone from funny to insulting.

"We had been friends on Facebook for about seven months, but until earlier this month there was nothing like this," the woman said. "I'm not innocent in this, I mean at first I figured he was just a lonely, nice man who wanted to talk. As the messages got suggestive, I couldn't believe it, but I didn't end it. I honestly thought it was funny in a weird way. But when he started talking about money, like I was a prostitute, that's when it hit me."

In messages from Archer's account, the judge's personal cell phone number was sent to the woman and in some conversations he asked her to call him at his office. Those requests came during business hours at the Tallapoosa County Probate Office.

A picture of Archer, dressed in a T-shirt, is also included in one messenger exchange. A photo of a man nude below the waist was also sent to the woman from Archer's cell phone number. The background in the picture closely resembles the bathroom tile in the Tallapoosa County Courthouse.

In one exchange, Archer made repeated requests for a nude picture of the woman below the waist. After making several excuses and trying to stave off the request, the woman said she sent him a picture she found on the Internet of someone else.

"I did send him a picture, but it wasn't me," the woman said. "I admit that I did talk to him and respond. I guess I could have just ended it and unfriended him, but he is an elected official – a judge. I couldn't believe that he was doing this and wanted to just see how far he would go. I mean some of the stuff he was saying, I had to look it up. There were some pretty strange things he wanted."

The woman even asked Archer: "Is it illegal for someone who holds elected county office to ask for sexual favors in exchange for money and ask the person to call their private line while they are at work?"

The return message from Archer read: "Not if you call their personal cell #."

Archer said he is sorry for the embarrassment his actions will cause others.

"I have apologized to her and I am sorry for being lead into this embarrassing situation," Archer said. "I'm sorry for the embarrassment this will bring on people who mean so much to me."

Archer said he first met the woman a few years ago when she was in his court over a situation involving her then husband. Archer said he did become friends with her over social media, but did not have any face-to-face contact with her, only electronic conversations.

Archer was first elected on Nov. 6, 2012 to serve a six-year term. Archer previously served as a county commissioner in Shelby County.

Archer said his mistake should serve as a lesson to everyone about social media.

“Don’t just accept someone’s request to be your friend,” Archer said. “When conversing with someone, one needs to be careful in your wording that goes back and forth. Pictures sent are there forever. Again, this is something I will have to live with the rest of my life.

“I should have known better, but I can’t take it back. All that I can do at this point is ask my wife of 47 years, my children, my church family, friends and the people of Tallapoosa County to forgive me.



Report: Probate judge sent sexually explicit messages to woman he met in court

A Tallapoosa County probate judge admitted sending sexually explicit Facebook messages and text messages to a woman he met in his courtroom, **according to the Alexander City Outlook.**

The 37-year-old woman, who asked to remain anonymous, supplied copies of her conversations with Judge Leon Archer to the newspaper. Their conversations began in early January and quickly became sexually suggestive, including one that read "What you got going today... I got some money I need to spend."

He asked her to call him during business hours, sent her a photo of a man nude from the waist down and asked the woman to send nude photos in return.

The woman admitted that she was not entirely blameless, but that she assumed he was lonely and just wanted someone to talk to.

Archer said he got caught up in the conversations and apologized for his poor judgement, **the Outlook reported.**

"I should have known better, but I can't take it back," Archer said. "All that I can do at this point is ask my wife of 47 years, my children, my church family, friends and the people of Tallapoosa County to forgive me."

Archer, who became a probate judge in 2012, was among dozens of judges across Alabama **who were conflicted over granting marriages to gay couples.** He previously served as a Shelby County commissioner and a Tallapoosa County commissioner.



Tallahassee County Probate Court Judge Leon Archer admitted Friday that he had sent sexually explicit conversations via social media messenger that included suggestive language, photos and propositions for sexual acts.


A 37-year-old female Facebook friend, who asked that her name not be used, but did meet face-to-face with *The Outlook*, has supplied the newspaper with electronic copies of her conversations with Archer.

The online conversations began in early January and escalated from friendly banter to sexually suggestive requests in a matter of days, according to time stamps on the messages.

Archer, who has been married for 47 years, apologized for his "very poor judgment."

"I'm not going to lie about it or deny it," Archer said after viewing prints of the messages Friday. "I'm not a perfect man and I have done a lot of things that I am not proud of and this may be one of the worst. I got caught up while on social media

with my language and pictures going back and forth. It got out of hand and I should have known better.

"This shows a lapse of judgment - very poor judgment. Being a judge, I should be above that and adhere to a higher standard. I feel like I have voided that trust."

The messages are from Archer's Facebook account, which features his official probate court judge portrait. One message even includes the offer of money if the woman were to meet with him.

"What you got going today ... I got some money I need to spend," Archer's messaged read.

Archer apparently shut down his Facebook account over the weekend.

Employees at the Probate Office in Dadeville said that Archer had not been in the office as of Wednesday afternoon. They said that it has remained business as usual and that there have been only a few visitors who asked about the situation.

Archer, who last year discontinued officiating marriages at the courthouse when he cited moral objections to same sex marriages, never said specifically what he wanted to spend the money on, which is a legal requirement to the crime known as soliciting for prostitution.

The woman said when money was mentioned, she felt the banter had gone from funny to insulting.

"We had been friends on Facebook for about seven months, but until earlier this month there was nothing like this," the woman said. "I'm not innocent in this, I mean at first I figured he was just a lonely, nice man who wanted to talk. As

the messages got suggestive, I couldn't believe it, but I didn't end it. I honestly thought it was funny in a weird way. But when he started talking about money, like I was a prostitute, that's when it hit me."

"Don't just accept someone's request to be your friend," Archer said. "When conversing with someone, one needs to be careful in your wording that goes back and forth. Pictures sent are there forever. Again, this is something I will have to live with the rest of my life."

"I should have known better, but I can't take it back. All that I can do at this point is ask my wife of 47 years, my children, my church family, friends and the people of Tallapoosa County to forgive me."

"I am sorry and I apologize."
