# JUDGE ANITA KELLY'S MOTION FOR ORDER SHORTENING TIME FOR RESPONSE

Judge Anita Kelly, pursuant to Rule 34(b), Alabama Rules of Civil Procedure, and Rule 10, Rules of Procedure for the Alabama Court of the Judiciary, moves the Court of the Judiciary for an Order shortening the time, until 12:00 noon on Thursday, August 31, 2017. for the Judicial Inquiry Commission ("JIC") to respond to Judge Kelly's First Request for Production. (Those requests, served this date, are marked as Exhibit "A" and annexed hereto.)

## FIRST REQUEST FOR PRODUCTION
