

SUPREME COURT AND STATE LAW LIBRARY INTERNET ACCESS AND USE POLICY STATEMENT

GENERAL INFORMATION

The Library staff can only provide limited instructions with computer use. Data will not be typed or entered for you. The Library reserves the right to clear all information saved on a computer's hard drive without prior notice. Save all work to a removable data storage device (floppy disk, CD, or jump drive) or email all research results to an e-mail account.

Users may NOT:

- **Unlawfully reproduce and/or distribute copyrighted material**
- **Save any document to the hard drive.**
- **Unplug or move any Library equipment**
- **Violate or encourage others to violate federal, state, or local laws**
 - **Such as viewing, displaying, transmitting, downloading, or printing obscene material, material that violates the law relating to child pornography, material harmful to minors, or transmitting offensive, harassing, or threatening messages**
- **Access online games, chats, or user groups**
- **Use computers for commercial or private financial gain**
- **Cause harm to the Library, others, or any property**
 - **Such as downloading software, or copying, modifying, or deleting system files, "hacking" or any form of unauthorized access to other computers, networks, or information systems. This includes but is not limited to installing software and/or changing settings on a computer, sending viruses, or other forms of vandalism.**
- **Jeopardize the security of access of the computer network or other networks**
 - **Such as evading system security or network access rights, using one's own software, altering settings, damaging or modifying computer equipment or software, or connecting personal equipment or peripherals to Library's equipment.**
