**JUDGE ANITA KELLY’S REQUEST TO JUDICIAL INQUIRY COMMISSION  
FOR NOTICE AND PRODUCTION OF “OTHER ACTS” EVIDENCE  
PURSUANT TO ALA.R.EVID. 404(b)**

Pursuant to Alabama Rule of Evidence 404(b), Judge Anita Kelly requests that the Judicial Inquiry Commission (JIC) provide Judge Kelly notice, and produce to her all evidence, of all “other crimes, wrongs, or acts” that JIC may offer in evidence or otherwise seek to use at trial in this matter, whether as substantive evidence in its case in chief, in rebuttal, for impeachment, or for any other purpose; and otherwise state in detail the nature of any such evidence JIC may offer or otherwise seek to use at trial in this matter.

For purposes of this request, the term “other crimes, wrongs, or acts” includes but is not limited to any act or any specific case (whether juvenile dependency, juvenile delinquency, child support, domestic relations, or other) not specifically pleaded and identified in the Second Amended Complaint. Judge Kelly specifically requests that JIC provide her such notice, and produce to her all such evidence, within seven (7) days of the date of this request.
