**UNOPPOSED MOTION TO EXTEND DEADLINE
FOR IDENTIFYING AND PRODUCING EXHIBITS**

Judge Anita Kelly respectfully moves, without opposition, to extend the deadlines relating to identification and production of exhibits to this Friday, March 2 at 12:00 noon. In support Judge Kelly shows the following:

1. In the scheduling order entered January 29, 2018, the Court directed as follows regarding the identification and production of exhibits:

On or before February 28, 2018, the parties shall provide to each other and to the Court a list designating all exhibits each party plans to introduce at the trial in this matter; if a copy of any exhibit has not yet been provided to the other party and to the Court, a copy of such exhibit shall be provided to the other party and the Court on or before February 28, 2018.

2. Notwithstanding the best and most diligent efforts of Judge Kelly and counsel, it will be difficult, if not impossible, for Judge Kelly to comply fully as to all anticipated trial exhibits by the current deadline of tomorrow.

3. Accordingly, Judge Kelly requests that the Court extend by 36 hours the above deadlines as set forth in the January 29, 2018 scheduling order, from tomorrow to 12:00 noon on Friday, March 2, 2018.

4. Counsel for the Judicial Inquiry Commission have advised Judge Kelly's counsel that they do not oppose an extension of that length.

WHEREFORE, PREMISES CONSIDERED, Judge Kelly respectfully requests that the Court grant this motion, and enter an order extending the deadlines identified above to 12:00 noon on Friday, March 2, 2018.
