JOINT MOTION TO SET EXPEDITED HEARING

COMES NOW the Alabama Judicial Inquiry Commission ("the Commission") and District Judge Kim J. Chaney ("Judge Chaney") and hereby move this Honorable Court for an order expediting the setting of the public hearing required by Article VI, § 157 of the Constitution of Alabama, as amended, and expediting the adjudication of the Complaint contemporaneously filed with this motion in this case. As grounds therefore, the Commission and Judge Chaney show the following:

1. The interest of the administration of justice would best be served by an expeditious resolution of this Complaint.
2. Judge Chaney waives his right under Rule 5, Ala. R. P. Ct. Jud., to file an answer or other responsive pleading to the Complaint within thirty (30) days of its service upon him; waives his right under Rule 8, Ala. R. P. Ct. Jud., to thirty (30) days' notice of

the date and time for a hearing of the Complaint in this case and consents to a more expeditious setting of the hearing; and waives his right of appeal under Article VI, §157 of the Alabama Constitution to the Alabama Supreme Court if the Court of the Judiciary adopts the terms as laid out in the Agreement and Stipulation of the Parties.
