MOTION TO SET EXPEDITED HEARING

COMES NOW, the Alabama Judicial Inquiry Commission (hereinafter "the Commission") and hereby moves this Honorable Court for an order expediting the setting of the public hearing required by Article VI, § 157 of the Constitution of Alabama, as amended, and expediting the determination of the Complaint previously filed in this case. As grounds therefore, the Commission shows the following:

1. The interest of the administration of justice would best be served by an expeditious resolution of this Complaint.
2. The spirit of the Rules of Procedure promulgated for the Court of the Judiciary by the Alabama Supreme Court favor the prompt, expeditious resolution of complaints, e.g., see Rule 7, Ala. R. P. Ct. Jud., which favors "the prompt disposition of the proceedings pending before the court" and the avoidance of undue delay; and Rule 8, Ala. R. P. Ct.

Jud., which provides that "the court shall fix a date for hearing upon the complaint as expeditiously as possible."

3. For purposes of this expedited hearing, Judge Todd has waived her right under Rule 5, Ala. R. P. Ct. Jud., to file an answer or other responsive pleading to the Complaint within thirty (30) days of its service upon her and has also waived her right under Rule 8, Ala. R. P. Ct. Jud., to thirty (30) days' notice of the date and time for a hearing of the Complaint, and has consented to a more expeditious setting of the hearing.

WHEREFORE, premises considered, the Commission respectfully requests this Court set this matter for an expedited public hearing.
