ORDER

WHEREAS, the Supreme Court of Alabama is authorized by Art. VI, § 150, Ala. Const. 2022, to make and promulgate rules governing the administration of all courts and rules governing practice and procedure in all courts; and

WHEREAS, the Supreme Court of Alabama recognizes the desirability and necessity of establishing a schedule of fees for furnishing, upon request, copies of the records of the appellate courts;

THEREFORE, IT IS ORDERED that the clerks of the Supreme Court, the Court of Civil Appeals, and the Court of Criminal Appeals are authorized to charge the following fees for furnishing copies of the records and documents on file in these courts:

A hard copy of a document in paper format	A fee of \$5.00 for 1 – 10 pages and \$0.25 per page thereafter
A facsimile copy of a document	A fee of \$5.00 for 1 – 5 pages and \$1.00 per page thereafter
An electronic copy of a document that requires staff-assisted delivery on a digital-storage device (e.g., compact disc, USB drive, etc.) or through electronic means (e.g., via e-mail)	A fee of \$5.00 for 1 – 10 pages and \$0.25 per page thereafter
An electronic copy of a document contained in the appellate courts' online case-management system	See (1) the fee schedule for the public-access site of the appellate courts' current online case-management system or

(2) the fee schedule for the public-access site of any of the appellate courts' legacy online case-management systems, including ACIS Online

A copy of an audio recording submitted as evidence	A fee of \$10.00 per copy provided on a compact disc (CD)
A copy of a video recording submitted as evidence	A fee of \$15.00 per copy provided on a digital video disc (DVD)
Copies from microfilm	A fee of \$2.00 per page
Copies from microfiche	A fee of \$2.00 per page
Redacted copies of documents	A fee of \$2.00 per page
Certified copies of documents	A fee of \$2.00 per page
Archival copies (copies from the bound volumes of documents maintained at the Department of Archives and History)	A fee of \$2.00 per page

Fees collected pursuant to this order shall be paid into the Administrative Fund, pursuant to § 12-2-20, Ala. Code 1975, or the State Treasury to the credit of the Advanced Technology and Data Exchange Fund, pursuant to § 12-2-290, Ala. Code 1975, for the benefit of the appellate courts.
